The Commission met with presenter Amy Dent, Christian County Auditor, for her February 2019 monthly report. Auditor Dent presented her report. Presiding Commissioner Phillips suggested that the budget for 2020 reflect a reduction in the Jury Expense fund under the Circuit Court. Presiding Commissioner Phillips then asked Auditor Dent if the \$50,000.00 allotted from MPR for reimbursement to the Highway Department and the Sheriff's Department could go to other places in need. Auditor Dent answered that the County can purchase what it needs and then seek reimbursement from MPR.

Presiding Commissioner Phillips then inquired as to the budget for the Circuit Court Building. Auditor Dent answered that given all of the recent purchases, the budget is outside of the GMP, however, there are funds in

the County's budget set aside to cover the additional expenses. There was then further discussion about the budget for the Circuit Court Building. Western Commissioner Bilyeu moved to approve the Auditor's monthly report for February of 2019 as presented. Eastern Commissioner Robertson seconded the motion.

The Commission met with presenter Miranda Beadles, Christian County Highway Administrator, in regards to a bid opening for county-wide road resurfacing, materials, and aggregate. The bids were opened in the following order for the specified items:

- 1. Huff Asphalt chip and seal.
- 2. Donelson Construction crack seal, microsurfacing, and fog seal.
- 3. Clever Stone cold mix, all quarry materials.
- 4. Journagan hot mix and haul rates for hot mix.
- 5. Journagan quarry items for Reed Springs, Ozark, and McCracken quarries.
- 6. Blevins Asphalt hot mix and haul rates for hot mix, cold mix, chip and seal, and fog seal.
- 7. Young Kerans Construction cold mix.
- 8. Bailey Quarries quarry items, rock, and aggregate.

Highway Administrator Beadles will formulate a bid tab in order to compare prices, and will return to the Commission on Thursday, March 7, 2019 at 10:45 a.m. for an award recommendation. No action was taken.
