CORONAVIRUS AID, RELIEF, & ECONOMIC SECURITY ACT (CARES ACT)
PHASE I & PHASE II

CALL FOR APPLICATIONS

The County Commission, along with the CARES Act Committee, is accepting applications for Phase I of the Christian County, Missouri, CARES Act local government funding distributions. You have received this notice because your agency has been selected as an eligible group.

PROGRAM SCOPE & CRITERIA

The purpose of this program is to disburse funding received by Christian County to eligible groups within its boundaries. The CARES Act provides that payments from the fund may only be used to cover costs that:

1. Are necessary expenditures incurred due to the public health emergency with respect to the Coronavirus Disease 2019 (COVID-19);
2. Were not accounted for in the budget most recently approved as of March 27, 2020 (the date of enactment of the CARES Act) for the State or government;
3. Were incurred during the period that begins on March 1, 2020, and ends on December 30, 2020.

Phase I: Awards issued under Phase I agreements are based upon funding already spent due to the COVID-19 public health emergency. Applications should reflect COVID-19 related expenditures between March 1, 2020 and May 31, 2020.

Phase II: Awards issued under Phase II will address **PROPOSED** purchases related to the COVID-19 public health crisis after May 31, 2020. Application distribution and review dates are TBD.

APPLICATION GUIDELINES

Attached is a Project Application form that must be completed and returned to the CARES Act Committee along with supporting documentation.

Along with the Program Scope & Criteria, applicants should review documents and guidelines located on the Missouri State Treasurer's CARES Act website:

Applications will be evaluated by the CARES Act Committee and approved by the Christian County Commission. You will receive notification of our decision within thirty (30) days of an accepted application. For applicants receiving award, an Intergovernmental Agreement (IGA) or similar will be distributed for your approval and signature. We ask you return the IGA via US Mail or drop off to the Christian County Cares Act Committee located at 1106 W Jackson St, Ozark, MO 65721.

We look forward to receiving your applications.
