I, Kay Brown, Election Authority for the County of Christian, hereby certify the attached document to be a true, correct and complete abstract of all the votes cast in the General Municipal Election for the Nixa City Bond Issue in said city, held on April 8th, 2014, as shown by the returns from all the different voting polling places or precincts in said city, and as verified by the recount election board as provided in 115.589 RSMo.

On Tuesday, May 13, 2014, a recount was performed for the Nixa City Bond Election beginning at 9:00 a.m. and ending at 1:00 p.m. The recount was held in the Christian County Clerk's Office, conducted by sixteen disinterested registered voters that represented the City of Nixa. The City of Nixa needed a 57.14% majority for the bond election to pass but received fifty seven percent. The hand count for all the precincts showed an increase of five "YES" votes and an increase of six "NO" votes, for a total vote count of 3,056. The total votes cast of the recount are as follows:
