**PROPOSITION 1**

Shall Section 3.6 of the Nixa City Charter be amended as set forth in Ordinance No. 2411 to provide that Council vacancies shall be filled by Council appointment until the next available regular municipal election regardless of the length of the vacancy?

**Summary:** this proposal would change the way a vacant City Council seat is filled by removing the requirement to hold a special election if more than one year remains in the term. Under the new process, any vacancy would be filled by a Council appointee who serves until the next regular city election. At the election, voters would then choose a person to serve the rest of the unexpired term.
